Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS CONTEST IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. VOID WHERE PROHIBITED.

I. CONTEST PERIOD: The ""Slide" your TFCU credit card for a chance to win \$1000" Contest (the "Contest") begins at 12:00:00 AM Eastern Time ("ET") on June 24, 2021 ("Start Date") and ends at 11:59:59 PM ET on September 06, 2021 (the "Promotion Period"). The Contest is run by Timberland Federal Credit Union (the "Sponsor" and "Prize Supplier"). The official clock for purposes of the Contest is the computer of the Sponsor.

II. ELIGIBILITY: The Contest is open to all legal residents of the fifty (50) United States that are eighteen (18) years of age or older at the time of entry. Officers, contractors, directors, officials, committee members and employees of the Sponsor, and any of their respective parent companies, affiliates, franchisees, licensees, subsidiaries, advertising/promotion agencies, persons engaged in the development, production or distribution of materials for this Sweepstakes Contest (collectively, the "Released Parties") are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor decisions, which are final and binding in all matters related to the Contest. Proof of entering information is not considered proof of delivery to or receipt by Sponsor of an entry. The use of automated entry devices is prohibited and no mechanically reproduced entries are allowed; all such entries are void. Released Parties are not responsible for: lost, late, incomplete, illegible, incorrect, damaged, delayed, garbled, undelivered, or misdirected entries, which will be disqualified. All entries become the exclusive property of Sponsor and will not be acknowledged or returned.

IV. PERSONAL INFORMATION/OPT-IN: By entering the Contest, you consent for the Sponsor to obtain, use, and transfer your name, address and other information ("Personal Information") for the purpose of administering this Contest and such Personal Information will be kept by Sponsor for marketing purposes in accordance with its privacy policy (<https://www.timberlandfcu.org/privacy-notice.html>), as posted on the Web Site. The information that you provide in connection with the entry process will be used by Sponsor only, and will not be sold or provided to another company.

V. LIMITATIONS OF LIABILITY: If for any reason this Contest is not capable of running as planned for any reason, including, without limitation, due to infection by computer virus, worms, bugs, tampering, unauthorized intervention, fraud, technical failures, fire, flood, storm, or other natural cataclysm, riot, strike, civil commotion, government regulation, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest (or any part thereof), the Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to terminate, modify or suspend the Contest, in whole or in part, at any time, without notice and award the prize(s) using all non-suspect eligible entries received as of or after (if applicable) this termination or suspension date. Released Parties assume no responsibility for any incomplete, incorrect, or inaccurate information, whether caused by web site users, tampering, hacking, or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error. VI. PRIZES: There will be ONE (1) First Place Prize available to be awarded. First prize in this contest is \$1,000.00

VII. PRIZE WINNER SELECTION: Drawing will be held on September 13, 2021 at Timberland Federal Credit Union.

VIII. PRIZE TERMS AND CONDITIONS: Each prize winner ("Prize Winner") is required to comply with any and all applicable federal, state and local laws, rules and regulations. Each Prize Winner will be required to sign an Affidavit of Eligibility and Liability/Publicity Release and provide valid identification (collectively, the "Prize Acceptance Release"), and return it within seven (7) days of written notification or the prize will be forfeited and an alternate potential winner selected. If a prize or prize notification is returned as unclaimed or undeliverable to a potential winner, if potential winner cannot be reached within three (3) calendar days from the first notification attempt, if potential winner fails to return requisite documentation within the specified time period, or if a potential winner is not in compliance with these Official Rules, then such potential winner shall be disqualified and an alternate winner will be selected for the prize at issue.
